

**Minutes of Working Committee Meeting of PHDMA held on 29.01.2021

The 1st Working Committee Meeting of PHDMA was held virtually on 29.01.2021 at 12:30 PM through Microsoft Team under the Chairmanship of Member Secretary, PHDMA. The list of members attended the meeting are at Annexure-I.

a) **Agenda of the Meeting:-**

- i. Impact assessment of schemes related to livelihood and Human Development,
- ii. Phone based survey of schemes / programme to assess the feedback.
- iii. Evaluation of some flagship schemes and documentation.

b) **Decision taken:-** After through discussion with all the Members of the Working Committee of PHDMA the following decisions were taken.

- i. The Members of Working Committee i.e., Directors Agriculture, ICDS&SW, Project Director, OPEPA, Director ST, Director Watershed, Director Fisheries, Director Horticulture, Director Animal Husbandry, Director NRLM, Director Special Project Panchayati Raj Department shall identify two schemes for which PHDMA will be commissioning for collecting testimonials (i.e., 50 stories) from each schemes and publish impact analysis report.
- ii. PHDMA shall endeavor to access the feedback directly from the beneficiaries of controlled irrigation and other human development oriented schemes through phone based survey initiatives.
